Summary of Duties

Under the general direction of the Clinical Manager, the Physiotherapist completes an assessment of clients referred to the physiotherapy service and identifies problem areas; establishes written treatment goals and plans to address client problem areas (which may include use of Applied Behaviour Analysis Principles and Strategies) in collaboration with client, family and/or alternate caregivers; provides direct and indirect client care in accordance with the treatment plan; evaluates the outcome of physiotherapy intervention on identified problems; maintains communication with all other team members regarding client care; participates with other organizations within the community; documents physiotherapy involvement in client care; oversees activities in the physiotherapy area which may be carried out by the Therapy Assistants; ensures that the environment of the physiotherapy treatment area meets client's needs; maintains clinical competence; maintains communication with all other staff members; supports departmental/Centre efforts in Quality Management activities, as required; participates in education, orientation and public relations, as required; maintains a safe work environment; performs designated administrative duties; performs other related duties, as assigned.
